AGENCY EXCELLENCE

United Way of Union County (UWUC) is open and transparent with all financial records. Monthly statements are compiled and the annual audit is conducted by an independent firm. UWUC continues to meet all 20 Standards for charitable accountability established by the Better Business Bureau. We also maintain Charity Navigator accreditation and achieved the Platinum Seal of Transparency, the highest rating by GuideStar.

MEMBERSHIP REQUIREMENTS

United Way of Union County meets all membership requirements set forth by United Way Worldwide. Each year, United Way of Union County must prove that it meets 12 requirements for United Way Worldwide membership, along with 70 indicators that demonstrate it embodies the intent of the membership requirements.
